SPECIAL MEETING**

The special meeting of the Great Meadows Regional Board of Education was held on Wednesday July 22, 2020 via the virtual platform – Google Meets, Independence Township. The meeting was called to order at 7:02 PM by President Douglas Smith. The following statement was read that adequate notice of the meeting had been given in accordance with the Open Public Meetings Act. The New Jersey Open Public Meetings Law was enacted to ensure the right of the public to have advance notice of and to attend the meetings of public bodies at which any business affecting their interest is discussed or acted upon.

**WHEREAS**, pursuant to N.J.S.A. 18A:7-8(j) and N.J.A.C. 6A:23A-3.1(a), the Board forwarded the proposed Employment Contract for Mr. Mai to the Executive County Superintendent for Warren County for approval, and has received written approval and notice from the Executive County Superintendent for Warren County that it has been determined that the proposed Employment Contract for Mr. Mai is in compliance with the Fiscal Accountability, Efficiency and Budgeting Regulations;

**IT IS HEREBY RESOLVED**, that, that the Board approves and adopts the Employment Contract for Mr. Mai as Superintendent, consistent with the terms and conditions set forth therein, and as approved by the Interim Executive County Superintendent for Warren County, per N.J.S.A. 18A:7-8(j) and N.J.A.C. 6A:23A-3.1(a) the period of August 1, 2020 through June 30, 2024; and

**IT IS FURTHER RESOLVED**, the approved Employment Contract for Mr. Mai replaces and supersedes all prior Employment Contracts, both expressed and implied, between the parties hereto, and by approving and signing the approved new Employment Contract both the Board and Mr. Mai assent to a rescission of any and all prior contracts, as well as agreement to the terms herein, except as noted and provided for in the approved new Employment Contract for Mr. Mai.
