To assist the Board in operating the school district's transportation system in the most cost-effective manner, Great Meadows Regional School District Board of Education Policy 8613 (enclosed) allows a pupil's parent/guardian the option of waiving transportation services for the school year in accordance with the provisions of N.J.S.A. 18A:39-1c.

In order to waive transportation services, a pupil's parent/guardian is required to sign a written statement indicating the pupil waives transportation services for that school year. The written statement is enclosed, and can also be found on the GMRSD website. This form must be completed and returned to school only if you elect to waive transportation at this time.

Please note, in the event a parent/guardian of a pupil eligible for transportation services waives transportation services for that school year and circumstances change during that school year, the school district will reinstate the pupil's eligibility for transportation to and from school upon completion and return of the Transportation Reinstatement Form (enclosed and on website).

8613 - WAIVER OF PUPIL TRANSPORTATION

The Board of Education is required lo provide transportation services for Ilic school year In an elementary pupil living more than two miles from the public school of attendance or to a secondary school pupil living mole than two and one-half miles from the public school of attendance in accordance with lite provisions of N.J.S.A. 18A:39-1 etseg.

The Board shall determine pupil transportation needs and approve pupil transportation routes based on all pupils eligible for transportation in accordance with the provisions of NJ S.A. [8A:VM cl scq. mid any less than remote, courtesy busing, and/or hazardous route transportation determined by the Board of Education. However, while providing school bus scats for those pupils eligible for transportation each school year, the Board recognizes certain pupils eligible for transportation services voluntarily elect not to use the transportation services offered by the Board in operating lie school district's fransportation system in the most cost-effective manner, the Board may provide a pupil's paren/guardian lic option of waiving transportation services for that school year in accordance with the provisions of N.J.S.A. 18A:39-le, In the event tile Board provides this option, a pupil's parent/guardian will be required lo sign a written statement indicating lie pupil waives transportation set vices for Ih.t school year. The written sutement shall be in such form as determined by the New Jersey Depariment of Education

In the event a parent/guardian of a pupil eligible for transportation services waives transportation services for that school year and circumstances change during thin school year due to a family or economic hardship, the school district will reinstate the pupil's eligibility for transportation to und from school.
